Good Afternoon Marco,

The City of Brownsville did not recruit Dollar General. The Dollar General Corporation made a decision to build stores in Oregon. Brownsville was a community they targeted based on their independent market research. They have put stores in Philomath, Harrisburg, Oakridge, Bandon among other Oregon communities and are currently under construction in Sweet Home.

Private land is held by private property owners who can choose to sell to any private interest or individual of their personal choosing. The City cannot legally prevent any such transaction. The zoning laws allow Dollar General or any other business of a similar nature to locate within that zone, Volume Commercial, as an outright permitted use. The City has sent their construction information to appropriate reviewing agencies at the County and the State. The City is also ensuring that they comply with all local laws and public construction standards.

Cities the size of Brownsville do not build houses, stores, adult care facilities or any other private or non-profit endeavors.

I certainly understand your concern. I have heard the opinions of many on this issue. I think it is important to know that the City is legally powerless in this or any other kind of situation that the City or citizens view as harmful to local charm and character of Brownsville. The City worked through a three-year process on a medical and now soon to be recreational marijuana shop that most people in town did not want.

I understand the impacts to the downtown core. I lived through this 22 years ago when Wal-Mart located in Ottawa, Ohio. Just like then, the City does not have any legal ability to prevent such an endeavor.

The Dollar General and other outside interests will continue to be interested in towns such as Brownsville only if they can make a profit. Brownsville's proximity to I-5 is a major selling point. I truly hope the look and feel to Brownsville will not change. I appreciate your concerns and please contact if you would like to discuss this further. Thank you!
